



# MILGATE PRIMARY SCHOOL ATTENDANCE POLICY

## **PURPOSE**

The purpose of this policy is to

- ensure all children of compulsory school age are enrolled in a registered school and attend school every day the school is open for instruction
- ensure students, staff and parents/carers have a shared understanding of the importance of attending school
- explain to school staff and parents the key practices and procedures Milgate Primary School has in place to
  - o support, monitor and maintain student attendance
  - o record, monitor and follow up student absences.

## **SCOPE**

This policy applies to all students at Milgate Primary School.

This policy should be read in conjunction with the Department of Education and Training's <u>School Attendance</u> <u>Guidelines</u>. It does not replace or change the obligations of Milgate Primary School, parents and School Attendance Officers under legislation or the School Attendance Guidelines.

# **DEFINITION**

Parent – includes a guardian and every person who has parental responsibility for the child, including parental responsibility under the Family Law Act 1975 (Cth) and any person with whom a child normally or regularly resides.

#### **POLICY**

Schooling is compulsory for children and young people aged from 6 to 17 years (unless an exemption from attendance or enrolment has been granted).

Daily attendance is important for all children and young people to succeed in education and to ensure they do not fall behind both socially and developmentally. School participation maximises life opportunities for children and young people by providing them with education and support networks. School helps people to develop important skills, knowledge and values that set them up for further learning and participation in their community.

Students are expected to attend Milgate Primary School during normal school hours every day of each term unless:

- there is an approved exemption from school attendance for the student
- the student has a dual enrolment with another school and has only a partial enrolment in Milgate Primary School, or
- the student is registered for home schooling and has only a partial enrolment in Milgate Primary School for particular activities.

Both schools and parents have an important role to play in supporting students to attend school every day.

Milgate Primary School believes all students should attend school all day, every day when the school is open for instruction and is committed to working with its school community to encourage and support full school attendance.

Our school will identify individual students or cohorts who are vulnerable and whose attendance is at risk and/or declining and will work with these students and their parents to improve their attendance through a range of interventions and supports.

Students are committed to attending school every day, arriving on time and are prepared to learn. Our students are encouraged to approach a teacher and seek assistance if there are any issues that are affecting their attendance.

Milgate Primary School parents are committed to ensuring their child/children attend school on time every day when instruction is offered, to communicating openly with the school and providing valid explanations for any absence.

Parents will communicate with the relevant staff at Milgate Primary School about any issues affecting their child's attendance and work in partnership with the school to address any concerns.

Parents will provide a reasonable explanation for their child's absence from school and endeavour to schedule family holidays, appointments and other activities outside of school hours.

## Supporting and promoting attendance

Milgate Primary School's Student Wellbeing and Engagement Policy supports student attendance.

Our school also promotes student attendance by promoting the importance of regular attendance through the school newsletter, ensuring that parents are aware of their obligations to notify the school of their child's absence.

## **Recording attendance**

Milgate Primary School must record student attendance twice per day. This is necessary to:

- meet legislative requirements
- discharge Milgate Primary School's duty of care for all students

Attendance will be recorded by the classroom teacher using Compass at the start of the school day and after lunch. If students are in attendance at a school approved activity, the teacher in charge of the activity will record them as being present.

## **Recording absences**

For absences where there is no exemption in place, a parent must provide an explanation on each occasion to the school.

Parents are required to notify the school of a student's absence preferably in advance but no later than 9.30am on the day of absence.

This can be done by:

recording the absence on Compass

- contacting the office by phone or email
- email the classroom teacher

If a student is absent on a particular day and the school has not been previously notified by a parent, or the absence is otherwise unexplained, Milgate Primary School will notify parents by automatic SMS notification from Compass. Milgate Primary School will attempt to contact parents as soon as practicable on the same day of the unexplained absence, allowing time for the parent to respond.

Milgate Primary School will keep a record of the reason given for each absence. The Principal will determine if the explanation provided is a **reasonable excuse** for the purposes of the parent meeting their responsibilities under the <u>Education Training Reform Act 2006</u> (Vic) and the <u>School Attendance Guidelines</u>.

If Milgate Primary School considers that the parent has provided a **reasonable excuse** for their child's absence the absence will be marked as 'excused absence'.

If the school determines that no reasonable excuse has been provided, the absence will be marked as 'unexcused absence'.

The Principal has the discretion to accept a reason given by a parent for a student's absence. The Principal will generally excuse:

- medical and dental appointments, where out of hours appointments are not possible or appropriate
- bereavement or attendance at the funeral of a relative or friend of the student, including a student required to attend Sorry Business
- school refusal, if a plan is in place with the parent to address causes and support the student's return to school
- cultural observance if the parent/carer notifies the school in advance
- family holidays where the parent notifies the school in advance

If no explanation is provided by the parent within 10 school days of an absence, it will be recorded as an 'unexplained absence' and recorded on the student's file.

Parents will be notified if an absence has not been excused.

After 3 consecutive days of a student having an unexplained absence, the teacher will call the family to follow up on the child's absence.

After 5 consecutive days of unexplained absences, the Assistant Principal or Principal will call the family to follow up on the child's absence.

Ongoing unexplained late arrivals will also prompt follow-up by the Assistant Principal or Principal.

## Late arrivals and Early departures

At Milgate Primary School, classrooms will be open and supervised at 8.50am. Music will play over the school sound system to indicate that children must make their way to their classroom to ensure they are ready for learning time to commence at 9.00am.

Students arriving in the classroom after the 9.00am bell must present to the front office and will be issued with a late pass which is then given to the supervising teacher.

Unexplained late arrivals/early departures are monitored over a two week period and a phone call from the Assistant Principal/Principal will take place. Parents are required to explain late arrivals/early departures by entering an absence note on Compass.

Students are required for the full school day to ensure they are not missing valuable learning time. Whilst the school understands that there may be unavoidable instances where a child needs to be collected from school early for reasons such as medical appointments students are required to be at school until 3.30pm. Parents or guardians collecting students before the end of the school day are required to report to the office.

Any person picking up a child will be required to show photo ID before collecting an Early Departure pass.

Staff will record the students departure on Compass prior to parents collecting their child. Parents can enter an explanation into Compass before or after the early departure. If someone other than the parent needs to collect a student from school early, authorisation needs to be provided by the parent prior to collection through a phone call to the office on 9842 7744.

## Managing non-attendance and supporting student engagement

Where absences are of concern due to their nature or frequency, or where a student has been absent for more than five days, Milgate Primary School will work collaboratively with parents, the student, and other professionals, where appropriate, to develop strategies to improve attendance, including:

- establishing an Attendance Student Support Group
- implementing a Return to School Plan
- implementing an Individual Education Plan
- implementing a Student Absence Learning Plan for students who will be absent for an extended period
- arranging for assistance from relevant staff, e.g. Assistant Principals, Wellbeing leader

We understand from time to time that some students will need additional supports and assistance, and in collaboration with the student and their family, will endeavour to provide this support when it is required

## **Referral to School Attendance Officer**

If Milgate Primary School decides that it has exhausted strategies for addressing a student's unsatisfactory attendance, we may, in accordance with the School Attendance Guidelines, refer the non-attendance to a School Attendance Officer for further action.

If, from multiple attempts to contact with a parent, it becomes apparent that a student will not be returning to the school, the Principal may make a referral to a School Attendance Officer if:

- the student has been absent from school on at least five full days in the previous 12 months where:
  - o the parent has not provided a reasonable excuse for these absences; and
  - o measures to improve the student's attendance have been undertaken and have been unsuccessful
- the student's whereabouts are unknown and:
  - o the student has been absent for 10 consecutive school days; or
  - o no alternative education destination can be found for the student.
