

Dear Parents and Guardians,

*Milgate Primary School* is looking forward to another great year of teaching and learning and would like to advise you of the voluntary financial contributions for 2025. We are very proud of the enhanced educational experience that is provided here at Milgate which extends beyond the Victorian standard curriculum. Our aim is to develop and nurture well-rounded students by offering a wide range of learning opportunities.

Schools provide students with free instruction to fulfil the standard curriculum requirements, and we want to assure you that all contributions are voluntary. Nevertheless, Milgate Primary School also relies on a variety of locally raised funds for additional revenue which goes towards providing the high level of educational resources and experiences that you have come to expect.

Within our school this support has allowed us to:

- o Participate in the International Baccalaureate Primary Years Program to foster the development of the whole child (social, physical, emotional, and cultural aspects in addition to academic excellence).
- o Enrich the student experience through enhanced Music, Art and PE/Sport programs
- Supplement the Chinese Language (Mandarin) program by partnering with our Chinese sister school
   Experimental Primary School of Beijing Normal University
- o Continuously enhance the learning program through investing in ongoing learning technology and digital resources.
- o Improve the academic excellence of our students through continual professional development of staff to apply the best research and practice in the classroom.
- o Introduce STEM (Science, Technology, Engineering, and Mathematics) as a new specialist subject in 2025. This initiative reflects our dedication to equipping students with the skills and knowledge necessary to thrive in an increasingly technological and scientific world.
- o Upgrade our Grounds this year including the installation of the Year 1 and 2 playground, update the Foundation Courtyard, install two new Gaga Pits and two new Table Tennis tables. Next year the school is anticipating installing playground equipment for Year 3 & 4, new fencing on the basketball courts, provide campfire seating on the hill at the southern end of the school and a few other minor projects.
- Upgrade our buildings this year including a gas pressure upgrade to fix the heaters in the stadium, air conditioning and shelving in the Library, upgrade of the Stadium kitchen, upgrading the community room to create a dedicated STEM room. Next year the school is planning to upgrade the stadium roof skylights and continue with external building painting and maintenance works.
- o Continue to provide a variety of lunchtime clubs for students to engage in, leadership opportunities for students including wellbeing, house, cultural and school leaders programs

We would like to thank all families for their ongoing support as this ensures that we can continue to offer the best possible education and support to our students and their families.

*<u>Curriculum Contributions</u>*: items and activities which are necessary to support a student's learning of the curriculum.

# **FREE INSTRUCTION**

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the requirements of the Curriculum. This includes the Victorian Curriculum F-10, the Victorian Certificate of Education (VCE) including the VCE Vocational Major and the Victorian Pathways Certificate.
- Schools may invite parents to make a financial contribution to support the school.

## **PARENT PAYMENT REQUESTS**

Schools can request contributions from parents under three categories:

### **Curriculum Contributions**

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

### Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.
